## Special Board of Directors Meeting February 8, 2020 @ 11:00 AM

Board Members Present: Patrick Coates, Russ Dukeman, Steve Moore (Vice President), Beth Patterson, Kellye Rembert (Secretary), Greg Sheperd (President)

- 1. Greg Sheperd (President) called the meeting to order.
  - a. Mr. Sheperd asked for all to join in the Pledge of Allegiance.
  - b. Reminder of meeting conduct.
- 2. New Business
  - a. Presentation of Recommended Budget for 2020-2021.
  - b. Joe Patterson spoke on behalf of the Budget Committee
    - i. Mr. Patterson recognized the Budget Committee Members and their work on this budget.
    - ii. Mr. Patterson began with Budget Committee Goals for 2020-2021
    - iii. Recommended Dues and Assessments were presented with no increase in dues and a predicted 50% collection rate
    - iv. The committee recommends that there not be a "loss cap"
      - 1. One amenity should not be described as a loss and others as budget items
      - 2. Not everyone values the amenities the same way, so no two people would put together the same budget on their own
    - v. The committee recommends that whatever exists in the net operations after all of the fiscal obligations have been fulfilled be allocated to reserves.
  - c. The Budget Committee formally forwarded the proposed budget to the Board of Directors with consideration of the reserve allocations, summary totals to be used as a guide and no stop gaps (loss caps)
  - d. Respectfully submitted by Joe Patterson, Co-Chair; Sandy Popivchak, Co-Chair; Pam Halverson and Perry Slaton members
  - e. Greg Sheperd asked how the committee proposed we allocate to reserves
    - i. Response= Once total expenses have been med, the allocations would be above that to reserves
  - f. Sandy Popivchak noted that this is a very tight budget, so if collection rate goes below 50% there will be probable cuts to amenities
  - g. Mr. Sheperd asked the committee and Louise Moisan (General Manager) to put together a plan to justify the discrepancy in the Restaurant/Lounge budget sent forward as opposed to the committee's budget. They will provide.
